

# Golf Club at Red Rock Terms

## PAYMENT

- A non-refundable deposit will be required to secure the date of your event. The deposit will be applied toward your rental fee and/or final bill.
- There may be a refundable damage deposit is due 30 days prior to your event.
- Payment is due upon the receipt of invoice.
- Interest at a rate of 10% may be applied to invoices that remain unpaid after 14 days. If your event is cancelled 10 days or less prior to your date, you will be responsible for food and special-order beverage costs.

FOOD/BEVERAGES. It is strictly forbidden, without the express written consent of Red Rock Golf Club, as a group or individual, to bring any outside alcoholic or non-alcoholic beverages onto the premises. Guests under the age of 21 will not be served or permitted to consume any alcoholic beverages. The Golf Club at Red Rock retains the right to dismiss anyone violating this policy. The portable patio bar requires a \$300 minimum in alcohol expenditures. Outside food is not allowed without the express consent of Red Rock Golf Club. Cake or cupcakes from a reputable bakery may be brought on-site. Any ordered leftover food (other than cake or cupcakes) and beverages cannot be taken out of the facilities for food safety and insurance purposes.

EVENT CONFIRMATION. Confirmation of the number of people is required at least 10 business days prior to the event. A 20% service fee and sales tax will be added to all food and beverage items and included in your quote. Due to changes in food and beverage costs, events booked more than two months in advance have the possibility of variations in prices. You will be charged on your guaranteed count or the actual count, whichever is greater.

PROPERTY. All items brought in by the hosting organization or individual, and/or guests must be removed at the conclusion of the event. The Golf Club at Red Rock is not responsible for any loss or damage to your property before, during or after the event. Without prior arrangement, any items left after 24 hours will be disposed of by Red Rock. A cleanup/disposal fee may be charged. **NO CONFETTI**. The hosting organization/individual is responsible for any damage to the facility, golf carts or any other part of the Golf Club at Red Rock by participants, guests and/or other agents.

WEATHER. If conditions require cancellation of the event by the Golf Club at Red Rock, the outing may be rescheduled at the hosting organization's/individual's convenience based on availability. The contact person should call the course if inclement weather is in question.

INDEMNIFICATION. To the extent permitted by law, you agree to protect, indemnify, defend and hold harmless the Golf Club at Red Rock, its owners, employees and agents against all claims, losses or damages to persons or property, governmental charges or fines, and costs (including attorney fees) arising out of or connected with your function.

**NO CONFETTI**. We do not allow CONFETTI for any event.

## **COVID-19 WAIVER OF LIABILITY AND INDEMNIFICATION**

I/We hereby release and agree to hold the Golf Club at Red Rock, its employees and owners harmless from, and waive on behalf of myself, my heirs, and any personal representatives any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself and/or property that may be caused by any act, or failure to act of Red Rock, or that may otherwise arise in any way in connection with any services received from Red Rock.

I/We understand that this release discharges Red Rock from any liability or claim that I, my heirs, or any personal representatives may have against the facilities with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise from, or in connection to, any services received from Red Rock. This liability waiver and release extends to Red Rock together with all owners, partners, and employees.
